With regard to "drop shipment orders," Purchaser further understands and agrees that this exemption certificate is not applicable to any purchase whereby Seller is requested to make delivery to a third party who has commercial domicile in any State in which Purchaser not registered for sales and use tax purposes, and that Seller will invoice Purchaser for the sales and use tax at the statutory rate imposed by the ship-to jurisdiction, unless the Purchaser registers and submits a properly completed exemption certificate for his own account; or in the alternative, he requests from his customer, pursuant to his sale, (ship to designee) a properly completed exemption certificate with respect to the ship-to location (thereby exempting Seller as the accommodation manufacturer and shipper) and forwards such third party exemption certificate to the address stated above.
